

Van Hire Conditions (New Move-Ins)

- Must pay \$1,000.00 deposit (fully refundable if there is no damage).
- You have to refuel the van after use with Diesel (failure to refuel results in an automatic \$50.00 deduction from your deposit).
- You will be charged \$26.00 for every toll notice we received (or you can attach your own e-tag).
- You must have a credit card & current Driver Licence.
- You will be responsible for all speeding, parking & driving, infringements. You must comply with all road rules.
- You must be over the age of 25 years to hire the vehicle.
- You have the use of the van for 4hrs at a rate of \$49.00.
- Each hour or parts there off you will incur a rate of \$20.00 per hour, which will be paid on return of vehicle.
- The Vehicle must be returned to 602 Botany Rd, Alexandria no later than 5.00pm Monday to Saturdays & 3.30pm on Sundays.
- You must return the vehicle on the due date & time as per agreement.
- You are issued with a set of keys, if you lose the keys you will be charged \$60.00.
- The vehicle must be returned in a clean & tidy state.
- You are responsible for all tyre repairs & punctures.
- You and any Authorised Driver must only use the Vehicle on roads that are properly formed and constructed as a sealed, metalled or gravel road.
- You and any Authorised Driver must:
 - (a) Not allow the Vehicle to be used for any illegal purpose, race, contest or performance test of any kind;
 - (b) Not allow the Vehicle to be used to tow or push anything, unless authorised by Global;
 - (c) Not carry more passengers than may be properly accommodated by the seat belt restraints provided in the Vehicle, or carry a greater load than that for which it was built;
 - (d) Not be under the influence of alcohol, drugs or have a blood alcohol content that exceeds the legal limit in the State or Territory in which the Vehicle is driven;



- (e) Not allow the Vehicle to be used to carry passengers for payment of any kind;
- (f) Not use the Vehicle when it is damaged or unsafe;
- (g) Not use the Vehicle to transport goods, except in compliance with all necessary approvals, permits, licences and government requirements (to be obtained at Your cost) and in accordance with the Vehicle manufacturer's and Global's recommendations;
- (h) Not use the Vehicle for the conveyance or towing of any load which is incorrectly loaded or secured or is in excess of that for which the Vehicle was constructed;
- (i) Not, without Global's prior written consent, use the Vehicle to carry any inflammable substance which has a flash point under 22.8°C or any other explosive or corrosive substances; and
- (j) Not use the Vehicle in contravention of any law;

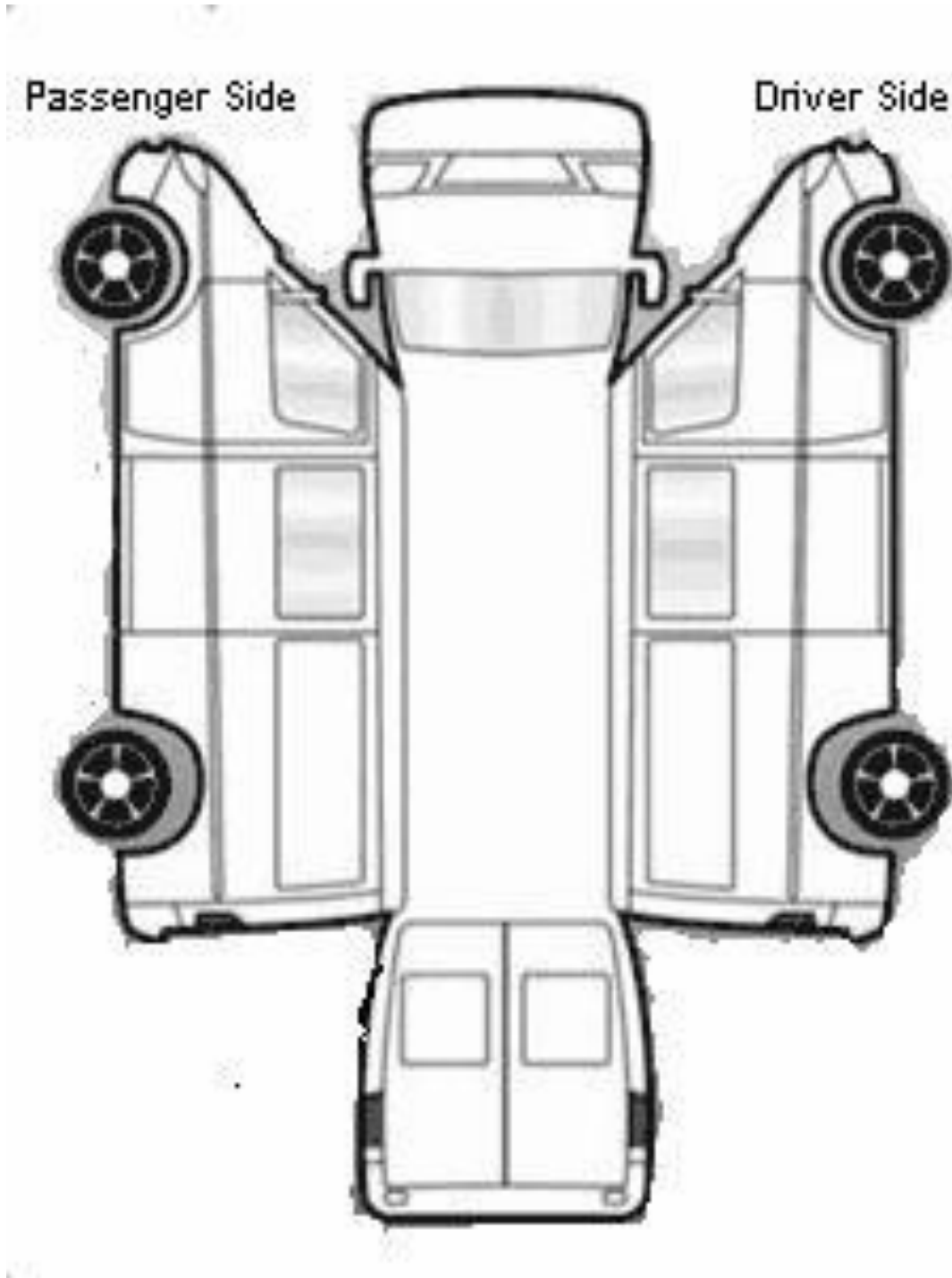
